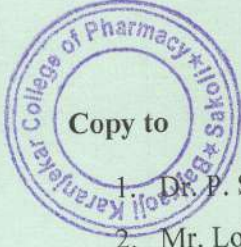

10. To discuss on collection of feedback from student, teacher, alumni of the institute of their opinions considering syllabus pattern.

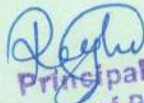
