

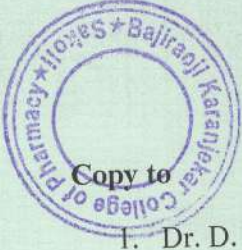

2. The action taken report/ compliance report of previous meeting was discussed and accepted after the review.
3. **Discussion on NBA SAR criteria wise**
Chairman Sir with the help of BKCP-NBA Coordinator discussed the every criteria of NBA. Some documentation is incomplete at that time, so coordinator sir requested to Principal Sir to fulfill the incomplete work with criterion members. All members are agree upon such participative decision.
